



## 2024 SCHOLARSHIP APPLICATION

*The Lithuanian Canadian Foundation (LCF) is a federally incorporated Canadian Registered Charity whose objective is to support, encourage and promote Lithuanian cultural and charitable purposes.*

### GUIDELINES

#### Eligibility

1. The LCF currently awards scholarships to students who:
  - are LCF members and are citizens or permanent residents of Canada;
  - will be studying at a post-secondary institution;
  - will be studying full-time or part-time towards a university degree or community college degree or certificate;
  - have previously received an LCF scholarship less than four (4) times; and,
  - are of Lithuanian descent.
2. Each applicant must write an original essay answering the question in Section B of this application.
3. Each applicant must include a **currently dated** reference letter written by an official (who is not related to the applicant) of a recognized institution/organization to/in which they belong/participate, which describes their involvement in extra-curricular activities/organizations in the Lithuanian community, or if there is no local Lithuanian community, in the local community at large over the last 2 years. These activities can be virtual.

The reference letter should be on the organization's letterhead, and the referree's position in the organization must be stated. The letter must state that the student is recommended for the LCF scholarship.
4. Scholarship applications from students planning to attend Lithuanian language courses, seminars or programs will be considered on a case-by-case basis.

#### Timeline

1. Complete applications, including all supporting documents must be received **via e-mail at [info@klfondas.org](mailto:info@klfondas.org) by August 31, 2024, 11:59 pm EDT** to be considered.
2. Applicants will be notified by email whether or not their application was approved **by September 30, 2024**.
3. Every scholarship recipient will be required to provide **proof of attendance** at a post-secondary institution, **such as a letter from the institution's Registrar or evidence of tuition being paid**. An initial letter of acceptance is not sufficient. Scholarship recipients will also be required to provide their Social Insurance Number (SIN) to the LCF for tax purposes. The LCF has the right to withhold scholarship funds from those who do not submit the required information to the LCF office **by October 31, 2024**.
4. The names of scholarship recipients will be publicly announced and the students may be asked to attend a presentation ceremony at an LCF sponsored or Lithuanian Canadian community event.
